General Information

Technical Regulations Purpose

This is to be read in conjunction with the [GNSW General Regulations Section](#).

The FIG Code of Points and Technical Regulations, and the Gymnastics Australia Technical Regulations provide governance for Aerobic Gymnastics (AER). This handbook provides AER in NSW with general and program information, technical regulations, event information and selection process, policies and forms.

The AER Gymsport Committee shall be master of its own procedures.

Where any event occurs that is not elsewhere provided in these regulations, any decision or action required shall be decided by a simple majority vote of the Committee, whose determination of the matter shall be final and not to be construed as having set a precedent.

Whereby error or omission any of the foregoing regulations shall require interpretation, the original intent of the Committee in the framing of the subject regulation shall prevail, rather than the letter of the law.

3. FIG CoP 2022 - 2024

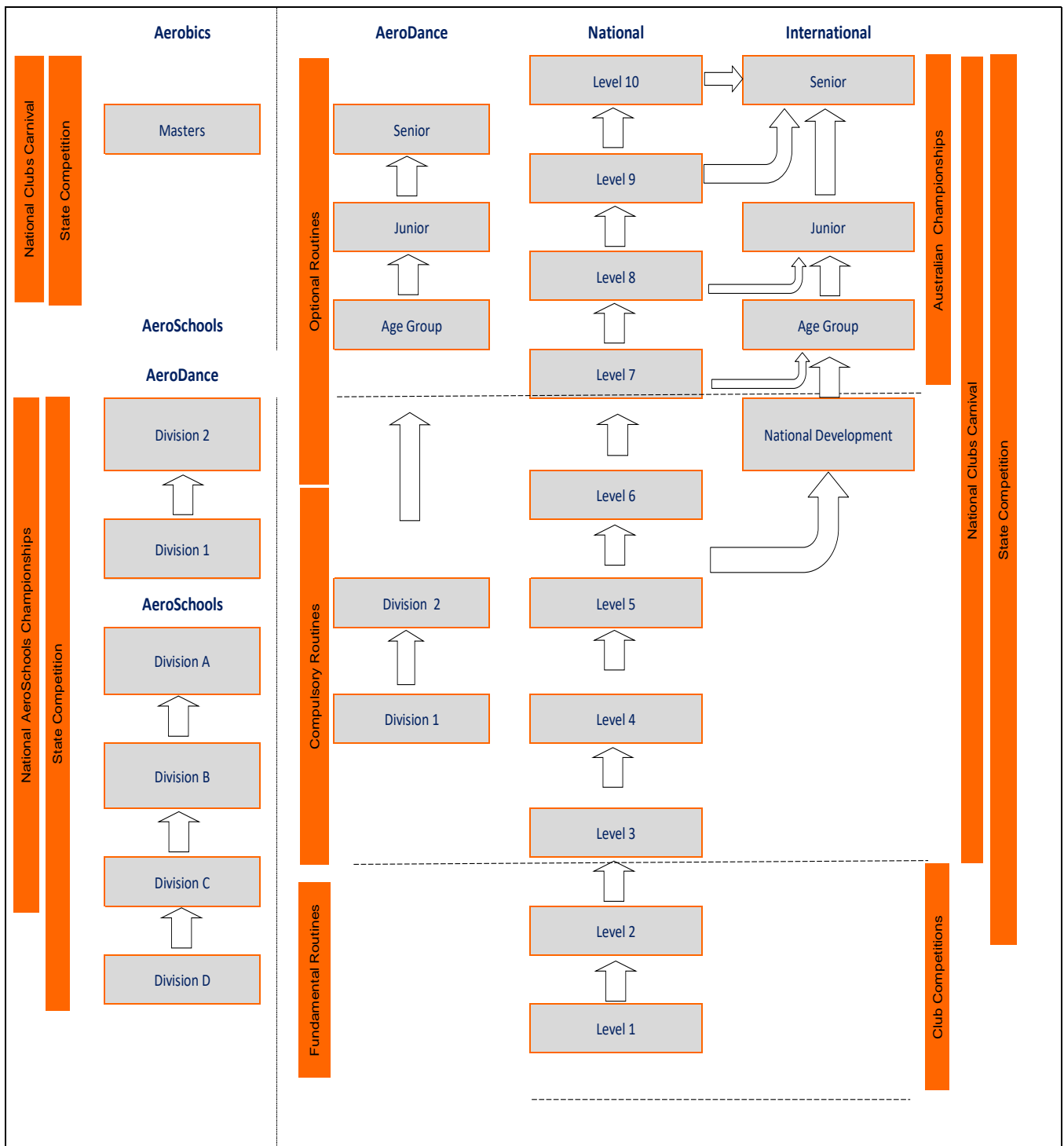
These rules will be used for aerobic gymnasts who intend competing within the International Stream.

Judge Roles

Judges may hold dual roles at NSW AER competitions, as long as they hold one role per session. For instance, a coach/judge may coach sessions 1 and 3 and judge session 2. An athlete/judge may compete in session 1 and 4 and judge session 2 and 3.

Judge Attire

Judges must meet the dress requirements as listed in the [GA Technical Regulations](#)



Additional Athlete Regulations

In order to compete in either NSW Trials, State or Australian Championships or any event sanctioned by Gymnastics NSW, all competitors must be registered with Gymnastics NSW with the exception of students competing in AeroSchools.

The student age category is the school year for competition.

Athlete Attire

Attire regulations apply for all GNSW events:

Competition attire:

- International and Levels Athletes: Competition attire should follow the specification listed in the Australian Levels Program and FIG Code of Points.
- AeroSchools Division: Competition attire should follow the specification listed in the AeroSchools manual.
- In addition to the above requirements athletes not participating in National events please refer the [General Regulations](#) attire.

Award Presentation Attire:

- AeroSchools Students are required to wear club/school tracksuit for presentations of awards.
- Levels and International gymnasts are required to wear club tracksuit for presentation of awards unless otherwise instructed at the competition venue.

Event Information

Competition Structure

Competitions for Aerobic Gymnastics across 2024 in NSW will be combined into two seasons for Senior & Junior and AeroSchools later in the calendar year

1. NSW Aerobics: which includes International, Levels 7-10 & AeroDance (optional)
 - Senior State Team Trial
 - Senior State Championships
 - State Team Selection Trial

International Stream routines are choreographed according to the 2022 - 2024 FIG Code of Points.

Levels 7 -10 Stream routines are choreographed according to the information supplied in the Gymnastics Australia Aerobic Gymnastics Australian Levels Program 2023 and Beyond.

2. NSW Aerobics & AeroSchools: which includes Levels 2-6, AeroDance Division 1 & Division 2 and AeroSchool Divisions.
 - Junior Trial 1 & Junior Trial 2
 - Junior State Championships (Level 3-6, AeroDance Divisions)
 - AeroSchools State Championships

Levels 2 -6 routines are choreographed according to the information supplied in the Gymnastics Australia Aerobic Gymnastics Australian Levels Program 2023 and Beyond.

AeroSchools routines are choreographed according to the information supplied in the Gymnastics Australia AeroSchools Program 2023 -2025.

Music Requirements

AeroDance , Level 6 -10 and International optional routine music must be submitted through the [Official Music Submission Form](#) by the required date prior to each competition.

AeroDance Divisions 1 & 2, Levels 2–6 compulsory music will be supplied by GNSW for the event.

AeroSchools music will be supplied by GNSW for the event.

Please refer to the [General Regulations Website](#) – Club Regulations – Music Submission Section – for all format, labelling and submission dates and any penalties that may apply.

Difficulty Sheets

Difficulty Documentation Forms must be completed for each gymnast and multiple entered for Levels 7- 10 & International. Difficulty Documentation Forms must be received by 5pm 2 days prior to competition date. For example, if the competition is scheduled on Saturday, the difficulty forms must be received by 5pm on the proceeding Thursday.

Specific Event Requirements

Entry Requirements & Rules

- All athletes, including AeroSchools athletes entering an NSW event must comply with all rules and regulations as per the NSW event policy and [GNSW Technical Regulations](#). School competing in AeroSchools are not required to be affiliated as a club to attend competition.
- The gymnast/coach choose one “stream” of competition from Levels or International, at the beginning of the competition year and remain within this stream for the calendar year.
 - Athletes may additionally compete in AeroSchools competitions.
 - Athletes may also compete in the AeroDance Stream or the AeroDance Divisions Stream as an additional stream of competition.
- An athlete who competed in AeroDance Junior, Intermediate, Senior is not eligible for AeroDance Division 1 & 2, other than in AeroSchools events.
- An athlete who competed in Level 7- 10, International are not eligible to compete in Levels 2 – 6, other than in AeroSchools events.
- Athlete in Level 7-10 may compete in AeroDance Division 2 if they have not competed in any of the AeroDance optional routines.
- Level 2 - 6 routines will follow the GA current ALP including errata.
- AeroSchools routines will follow the GA AeroSchools program including errata.
- Level 7 - 10 routines will follow the GA current ALP including errata. Level 7-10 routines are optional routines and should be constructed using special routine requirements that factor in safety and sequential skill development.
- Level 7-10 or international athletes may only participate in AeroSchools Division A and AeroSchools AeroDance Division 2.
- Athletes can change stream by applying in writing to the NSW AER GC, who then will seek approval from the National commission.
- Athlete’s may move up a level/s within a stream during the calendar year. Coaches and Clubs are responsible for their athletes, such that they are suitably prepared to move to higher level/s.
- Athletes seeking to move down levels within a calendar year must apply by written application from the club to the NSW AER GC. The AER GC will consider the individual merits and circumstances of the application before making a decision. Determination of the matter shall be final and not to be construed as having set a precedent.
- Levels athletes can compete in a maximum of 4 routines.
- International athletes can compete in a maximum of 3 routines.

State Championship Entry Requirements

To be eligible to enter the NSW State Championships all aerobic gymnasts are required to attend the GNSW Senior State Team Trial and compete in the division/s they wish to compete within at the State Championships in 2024.

To be eligible to enter the State Team Selection Trial all aerobic gymnasts are required to attend the GNSW State Championships.

Special Consideration

Special Consideration may be requested where a competitor is unable to compete in the trial but wishes to compete at the NSW State Championships.

Special consideration may be requested where a competitor is unable to compete at NSW State Championships but wishes to attend State Team Selection trial.

The Club must submit an application for special consideration via JotForm [LINK](#) with supporting documentation within 24hrs of the conclusion of the final NSW Trial. Valid reasons include but are not limited to illness, injury, attendance at international competition and family tragedy. Special consideration will be assessed and granted on a case-by-case basis.

AeroSchools State Championships Entry Requirements

To be eligible to enter the NSW AeroSchools State Championships, students must abide by the eligibility rules of GNSW.

Students are entered into AeroSchools State Championships through their schools who are responsible for certifying the eligibility of students representing the school.

Athlete Selection Process to Australian AeroSchools Championships

AeroSchools Multiple and Teams will advance to the Australian AeroSchools Championships as stated in the GA AeroSchools Manual.

Tied Scores

In case of a tie at any place in competition, the tie will be broken based on the following criteria in this order:

1. The highest total score in Execution
2. The highest total score in Artistic
3. The highest total score in Difficulty

If there is still a tie, the tie will not be broken

Protesting Scores

Enquiries will not be allowed at GNSW AER events; the judges' decision is final.



Awards

- AeroSchools Champion School will include results obtained from AeroSchools State Championships only.
- Champion Club will include results obtained from Senior and Junior State Championships.

AeroSchools Champion School trophy will be awarded at AeroSchools State Championships.

Club Champion trophy will be awarded at Junior State Championship.

Selection Process

Australian Championships NSW State Team

Selection Committee

Selection of the State Team will be made by the NSW AER GC following the final selection competition. The final decision will be submitted to NSWGA Board for ratification.

The following criterion is used in conjunction with Gymnastics NSW Selection Policy to determine state team selections.

Official Selection Criteria and Process

Please refer to the [GNSW State Team Website](#) and Selection Policy for information.

Athlete Selection Criteria to Australian Championships

Please refer to the Gymnastics NSW Selection Policy covering eligibility criteria, selection requirements and roles and responsibilities available on the GNSW website and [GNSW State Team Website](#). AER specific selection criteria can be found below.

To be eligible for consideration by the Selection Committee for selection onto the State Team an athlete must:

1. Be a registered member of Gymnastics NSW.
2. Compete at the NSW State Championships and NSW State Team Selection Trial.
3. Levels 7-10, AeroDance and International, must obtain a score equal to or higher than the GNSW qualification score in the level the athlete seeks selection in, at NSW State Championships or NSW State Team Selection Trial.
4. For athletes in Level 7–10 Individual, Multiple, Group there is no limit on numbers, provided those athletes have met the State Team eligibility criteria and qualifying requirements.
5. For athletes in AeroDance Team(12+ years – Age Group, Junior, Senior) there is no limit on number of teams provided those athletes have met the State Team eligibility criteria and qualifying requirements.
6. For athletes in the international stream (Age Group, Junior, Senior), there is no limit on the number of athletes selected to the NSW State Team, provided those athletes have met the State Team eligibility criteria and qualifying requirements.

Extenuating circumstances

Should a gymnast who has entered Senior State Championships and State Team Selection Trial be unable to compete at any of the events due to illness, injury or extenuating circumstances, they must follow the procedure for consideration of extenuating circumstances as outlined below.

- If illness or injury, a medical certificate **MUST** be submitted [online](#) to the EPPO. This certificate should be dated prior to the event or no later than 24 hours after the start of the missed competition.
- [A letter of consideration](#) where the gymnast has been unable to attend the event due to extenuating circumstances. The final decision as to whether the extenuating circumstances are acceptable shall reside with the Selection Committee.
- If for any other reason a gymnast cannot comply with the above, contact the EPPO before leaving the event.

The GNSW AER State Team will be named after the completion of State Selection Trial BUT will not be ratified until

- The State Team Selection Trial scores have been audited.
- 24 hours after the entire competition has concluded and the AER GC is in receipt of any special consideration requests; and
- The GNSW Board of Management has accepted all team members as being suitable to represent their State.

Should there be any changes to the team named at State Selection Trial following determination of special consideration requests and GNSW Board ratification, the AER GC will immediately advise the affected gymnasts and then publish the final GNSW AER State Team on the GNSW website.

Please note: The following criteria are to be used in conjunction with the Gymnastics NSW Selection Policy. Any gymnast, coach, or judge, financially in debt, to GNSW or GA will not be eligible for selection in a State Team. Any financial difficulties should be referred to the EPPO where options to resolve the debt can be considered.
